Each hereby affirms his/her/ its respective ability and competency to enter into and full intent to be legally bound by this agreement, with full exchange and receipt of good and valuable consideration between both parties without duress. Service is commenced upon signature of this agreement and agreements upon the terms and conditions are confirmed and ratified by this written Agreement as follows without waiver of IFEDOC's rights:

- All Students are referred by the Institute to various locations.
  At no time shall an individual contractor place a student under his/her services.
- 2. In order to ensure compliance with the state approved application, the curriculum materials will be provided by the Institute and will be distributed by the Institute. This will also ensure the uniformity of instruction and assessment. The independent contractor is required to submit to the Institute the following:
  - a. Pretest, mid-term and post test results per student. Final test results, original student work, and all class materials. The contractor will hand carry these documents to the office.
  - b. All tests provided by the head office.
  - c. Monthly progress reports entered for each student before the 3<sup>rd</sup> of each month.
  - d. All original documents to verify that a minimum of six (6) hours of professional development has been completed each year in reading and/or math before the last business day in February.

3.	All payments received in a twelve (12) month period (calendar year ending Dec. 31 <sup>st</sup> ) that tota \$600.00 or more will be reported to the IRS as MISCELLANEOUS INCOME (Form 1099)	
4.	. IFEDOC agrees to pay the Contractor \$ per hour, for doing the work outlined above. The following payments will be paid to the Contractor upon satisfactory completion of the work in the following manner and on the following dates:

- 5. The contractor and IFEDOC may agree to extra services and work, but any such extras must be set out and agreed to in writing by both the Contractor and the IFEDOC.
- 6. Under the Agreement the contractor understands and agrees that during the period of time service is being provided by IFEDOC and has referred students and for one (1) year after termination of services, contractor shall not use, instruct nor otherwise refer other contract services in any way for the same or similar services of or from any IFEDOC referred student(s), nor from any students identified through direct association with IFEDOC services. If contractor breaks this part of the Agreement contractor and IFEDOC agreed that damages to IFEDOC could be difficult to estimate, although great and irreparable. Contractor, therefore agrees that contractor will pay IFEDOC the sum of thirty-five hundred dollars (\$3,500) per student for any breach of this paragraph which is just compensation to IFEDOC for contractor's actions and not a penalty.
- 7. **CONFIDENTIALITY**. Both parties acknowledge that during the course of this Agreement, this contract does not give the rights for Contractors to use or resell techniques, methods, programs, designs, logos, artwork, photos, Trademarks, trade names, technologies, copyrighted materials or any other intellectual Property created without written consent of IFEDOC.

Both parties agree to treat all such information and the terms of this Agreement as confidential and to take all reasonable precautions against disclosure of such information for use or resell to unauthorized third parties during and after the terms of this agreement. All such precautions shall include without limitation informing all persons who by need have access to such information, documents, or materials that they are confidential and shall not be disclosed or provided access to unauthorized persons, any media and technological systems.

8. IFEDOC or Contractor may each terminate service without cause with at least two (2) weeks advance <u>written notice</u>. This agreement is the complete agreement between IFEDOC and the Contractor. No modification of this Agreement will be effective unless it is in writing and is signed by both parties. All portions of the Agreement are severable and if any provision is held invalid by a court of competent jurisdiction without reference to conflict of law principles which

9. , Contractor agrees to pay for and (Print name) provide current originals of the following documents: FBI Clearance, PA Criminal Record Check and PA Child Abuse Clearance.
